Pirlangimpi Store and Club has requested that they purchase one of the buses for the upcoming football season.

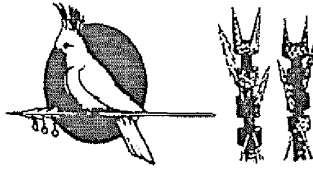

Below is a business proposal that the club is looking at:

1. We have been approached by the ferry about taking passengers to and from Milikapiti. At a latter date we might be able look at going to Garden Point.
2. Also we have a regular service picking up people and taking them to Milikapiti and back to the airport.
3. We have also just tapped into tourism.

We look at this as an opportunity for the club and further employment for someone to drive the bus.
