BACKGROUND

Over the last few years there have been a range of discussions and differing community views concerning the proposed development and implementation of By-Laws on the Tiwi Islands.

Councils may make by-laws for the good governance of their area.

By-Laws set out rules for the community which (if complied with) make the community a better place to live. They can also set out the standards, which are expected of residents and visitors in the Council area. It is important that the by-laws are clear and people know what is expected of them.
