### **3 GENERAL BUSINESS**

CEO Mark Goode explained the report and why there is no longer funding for some shire employee salaries in 2009-10.

In short, it is because:

- There has not been an increase in ongoing salary funding to pay for staff transitioned from CDEP in 2008-09
- TISC has had a reduction in real income due to the Local Government reform. TILG used to collect \$1.5m in rent and service fees. Under the Shires legislation, this income had reduced to \$350k of rates only.
- Incidentally these rates have not yet been paid due to delays in sending the rates out and ratepayers refusing to pay on the non-standard notices sent out. Non standard notices were sent out because the finance system's rates module was not yet being fully functional.

A long discussion took place about the report and the consequences of dismissing recently appointed shire employees. Council was very concerned and disappointed, saying that they were once again being set up to fail by NT and Commonwealth Government.

CEO Mark Goode explained that he has ongoing liaison with many Departments including DLGH over the past 12 months. He explained that unfortunately these conversations had not yet resulted in positive changes to the areas that would allow tangible improvements in service delivery to the community. The key areas of concern include:

- There has been a net reduction in funds available to TISC in 2009-10 compared to discretionary funding available to TILG in 2007-08
- There have been significantly increased costs due to Local Government reform, particularly in new staff costs and new IT costs. There has been no new funding to address these new costs
- There was and still is insufficient funding to deliver Core Services
- There has been no increase in ongoing salary funding to pay for new staff transitioned from CDEP in 2008-09
- There has been no change to the ability to pool grant funding to gain operational efficiencies
- There has been no reduction in the *Red Tape* in grant administration imposes significant administration costs to comply with.
