# INTRODUCTION

## 1. Scope

This Collection Specification applies to the following services:

- (a) Supply and install of 5 CCTV systems in Wurrumiyanga, Pirlangimpi and Milikapiti on the Tiwi Islands

## 2. Definitions

In this Collection Specification terms will, unless inconsistent with the context, have the meanings defined in the Conditions of Contract, except that a reference to **Clause** is a reference to a Clause in this Specification.

## 3. Description of specification

### 3.1 General

- (a) Council has funding for the supply and install 5 CCTV systems on major Council facilities on Bathurst and Melville Islands.
- (b) The tender includes supply **and** install of all equipment. All costs associated with travel or accommodation on the islands will be born by the contractor in the tender price.
- (c) If tenderers need to view the properties for pricing, all costs associated with travel and accommodation would be covered by the tenderer.
- (d) All tenders should be specific in the description of the make and model of the CCTV cameras included in the tender bid as well as clear explanation of the method of storage and retrieval of video footage and options for connection to wifi and internet
- (e) Tenders should include a timeline for delivery of the project.
