# 3.1 COMMUNITY HOUSING - PRESENTATION BY DES HARRIS - DEPT LOCAL GOVERNMENT, HOUSING AND REGIONAL SERVICES

Information on the various housing related activities happening on the Tiwi Islands such as SIHIP and property and tenancy management by Territory Housing.

#### General Discussions:

Henry Dunn asked for break up and costs. Jeff / Des Overall cost – Pirlangimpi and Milikapiti housing project will be completed in the next few months. Refurbishments range of cost ( 20 to 100,000). If any surplus money is available the discussions on how it will be used will be consulted with the Housing Reference Groups.

Concern raised that the Pirlangimpi community would not spend as much money as the other communities at Milikapiti and Nguiu.

Concerns of high rent . Des Harris AG and NTG put in money – previously – rent payments regime 23% of head tenant income. Maximum \$120.00 per week. Most people will not go over the \$120.00 rent.

Henry – How many new houses have been build on Melville Islands.

Marius P – Concerns that the advice made by the Housing Reference Group (HRG) to NTG – is not known to the rest the community and would like some feed back or information. The Housing Reference Group makes recommendations to the NTG, who will make the final decisions on housing taking into consideration the advice received from the HRG. So far decision made have come from the HRG and implemented by Gary Scaplen and John Mayer.

Des – Tenancy Officers roles are to ensure all tenants have a good understanding of the Tenancy Agreements.

Continues with HRG reports.

Manyi Question – Can tenants buying their own house with out having the 99 year Leasing arrangement on Melville Island – Des Harris offered to follow the question..
