



MINUTES OF THE MILIKAPITI LOCAL AUTHORITY MEETING HELD IN THE MILIKAPITI BOARD ROOM ON WEDNESDAY, 26 SEPTEMBER 2018 AT 10:00 AM

Due to a special welcoming of the Lord Mayor, Kon Vatskalis and staff from City of Darwin regarding the Sister City agreement between City of Darwin and Tiwi Islands Regional Council, the Milikapiti Local Authority was deferred until official business was dealt with. This meeting opened at 10:21 am.

Matters discussed:

Sister City Agreement

The initial agreement was signed by Mr George Brown, Lord Mayor of City of Darwin, Mr Gibson J Farmer, Council President of the Milikapiti Community Government Council, Mr Allan McGill, Chief Executive Officer and Mr Brian Miller, Council Clerk. This agreement was signed in 1999.

The new Sister City Agreement will now include the whole of Tiwi Islands not just Milikapiti community.

Lord Mayor and Chief Executive Officer from City of Darwin would like to work with Tiwi Islands Regional Council regarding the following:

1. Waste Management
2. Park Equipment
3. TOPROC
4. Territory Connect Return to County
5. Infrastructure and asset
6. Environmental Protection Authority (EPA)
7. Fees for Service

Andrew Tipungwuti, CEO of Tiwi Land Council have had discussions with Minister Nigel Scullion and he's supportive for the water park. A request from Tiwi Land Council (TLC) for a letter of support from Tiwi Islands Regional Council (TIRC).

Actions:

TIRC CEO to send a copy of the letter that was sent to the government outlining Council to cover the cost of the maintenance and requesting a one off capital to undertake the work.

General Manager Infrastructure to liaise with Scott Waters, CEO from City of Darwin to assist with waste and asset management process in place.

Council to liaise with Traditional Owners on how we can manage the waste management in each community.
