6.2 INTER-ISLAND FERRY NOT OPERATING ON THE DAY OF MIYARTUWI CLAN GROUP ELECTION.

On 26 June 2023 the Miyartuwi clan group election was held in the community of Pirlangimpi. On the same day the Tiwi Island Regional Council Inter-Island ferry operations was delayed as the ferry assisted the Sea-Link ferry due to a mechanical breakdown.

The Wurrumiyanga Local Authority members note that transport services between Bathurst and Melville are at times unreliable and this could be detrimental to community members participation in elections and meetings.
